Rolfe asked how many signers are on the account, there are 2. Karla asked if the district finances need the money, Dawn said no. Karla made a motion to keep it in the AOG account. It was seconded by multiple people. Amy asked if the vote can be changed next year, answer was yes. Amanda said she can't tell how much is coming into the district, Dawn said it is on her report. Kari offered an explanation of how the funds work. Wendy said if the district gets to a point where the money is needed a new motion can be made. Nate read the report from last year. Richard L gave a historic recount of using AOG monies to keep district afloat. Dawn reiterated district is financially stable. Motion passed unanimously.

Nate's expenses in Feb will be around \$850. No group contributions came in Dec.

The next meeting will be held February 5, 2026, at 6:30 pm. Kari H will do the 2nd Concept.
