Hi everybody!

First, thank you for the honor or serving as your CPC Chair this year. I've learned a lot and developed such incredible respect for the work Alcoholics Anonymous does in our district. I'm grateful to all of you who give your time, your attention and your heart to AA Service work.

The MSU Nursing School contact has asked us to give a CPC presentation to their nursing students on Friday, January 16th from 1-3. We have our presenters scheduled and they are excited. Al-Anon will, once again, join us for the presentation.

Rebekah P, D72 Treatment Chair, and I have reached out to Rimrock in Bozeman to begin discussing how D72 might be able to be useful to them. They are enthusiastic and will welcome our involvement and have asked us to give them some time to settle in first. They have suggested we regroup in February. What we've learned so far: Rimrock is planned to be an outpatient facility in Bozeman. Their patients are in their program from 3 - 24 months based on need. They are definitely interested in having us involved in bringing A.A. meetings on-site, and Rebekah and be talking with them more about needs, etc. early next year. Rimrock is also interested in exploring more about how we might be able to bring CPC Presentations (A.A. and Al-Anon) into their facility next year. As most of the Cedar Creek Staff has been retained, the need for an A.A./Al-Anon presentation is TBD. They also expressed a potential interest in getting AA Meeting Directories delivered, literature (TBD) and possibly want to connect with Bridging the Gap. More will be revealed. I will be scheduling a meeting in January for the Treatment, CPC, PI, BTG and Literature Chairs to begin talking about our potential involvement with Rimrock.

NEW TO REPORT:

Hi fam! I want to thank Amy and all of you who attended the workshop we had this afternoon before this meeting! As always, Amy did an awesome job putting it together! That movie was awesome!

I hope everyone had a good Turkey Day!

There are two new women's meetings starting up/have started- in Belgrade on Wednesdays from 5:30-6:30pm at the River Rock Church of the Nazarene and in Three Forks on Fridays from 5:30-6:30pm at Rebekah Hall.

These two meetings aren't on the schedule yet because we are supposed to give a 30 day trial period for new meetings before we add them to the official schedule.

I booked my flight, registered, and booked a hotel for the WCRAASC, which will be Feb. 27th – March 1st in Cedar Rapids, Iowa. If any ladies are planning to attend and would like to share a hotel room, please come talk to me after this meeting.

FOLLOW-UP INFORMATION:

1. Apparently, the wrong address to send Contributions to Area 40 was printed on our old meeting schedule. I gave Lynn (our Area Treasurer) Ashley's contact information, so hopefully it can get corrected the next time we print schedules! (Maybe it already got corrected!).

NEWS FROM GSO:

1. Bob W., who is the General Manager at the General Service Office, sent out an email to the fellowship, wanting everyone to know that, unfortunately, contributions are down considerably. He said "As members, we often say that when A.A. needs money, the Fellowship will respond. This is again one of those times. Your generosity has sustained us through very difficult times in the past. If your group is able, in the spirit of this season of gratitude, please consider a special contribution to the General Service Board"
 - a. Operating expenses before depreciation are \$19,146,151, a 1.8% decrease from the \$19,495,343 operating expense in the original budget adopted in January. The expense decrease is due to salary savings from vacant positions and savings in the Conference and Finance department budgets. Operating revenue is projected at \$20,283,275, unchanged from the original budget. The operating surplus before depreciation is \$1,137,124 which is \$681,498 after \$455,626 La Viña support.

There is a special Online Forum for Deaf AA Members on Saturday, 1/17, from 12pm-8pm. Please let me know if you have any questions!

The trustees' Cooperation with the Professional Community/Treatment and Accessibilities Committee (TCPC/T-A) affirmed the 2025 Conference Advisory Action to purchase a LinkedIn Premium Business plan on a trial basis for one year and looks forward to a progress report at the November meeting.

Three new Class A Trustees (nonalcoholic) have joined the General Service Board who will serve the Fellowship over the next six years: Tom Ivester, M.D., of Chapel Hill, North Carolina, Chief Clinical Officer at Novant Health; Kelly Parsley, of Helena, Montana, a professor of Health Sciences; and Veronica Ramirez, of Weslaco, Texas, retired Chief Probation Officer of the Eastern District of Louisiana

NEWS FROM AREA:

1. AREA BUDGET: 2025 budget is \$54,565

- As of 12/1/2025, contributions are \$41,229.42, spending is \$47,834.37
- Contributions are \$6,604.95 less than our spending, & are around 25% below the budget
- Spending is around 12% below the budget
- Operational balance: \$3,557.45
- Still around \$2,000 to spend in December (estimate)

2. Please keep in mind that Area 40 pays for a number of services so that the districts don't have to cover the costs directly. For example, our website, hotline, online meeting schedules, the technology for our Area Assemblies is top notch, & we offer climate controlled storage not

only for our historic Area 40 documents but also each of the districts can choose to use it for their archival materials as well. If your district, group, intergroup, or roundup has extra money, please consider sending some of it to Area 40 on its way down the triangle.

3. Next year, our budget will be \$60,925. I also want to check that everybody has the current address for contributions, including the printed schedules in your districts. If you see a printed schedule that includes the Area mailing address, please make sure it says:

9. Immediate Business – for DECEMBER 2025: 2 MINUTE TIMER FOR QUESTIONS/OPINIONS

- Tim - Review proposed spending plan for 2026
 - May need to correct adjusted Hall Rent payment back to what it was before because the Committee Chairs still use the hall despite the combined Nov/Dec meeting. Tim reduced it by one month but got told otherwise.
 - Steven asks is it reasonable to get rid of Quickbooks. Yes we voted to get rid of it. Ok.
 - Crystal states it is a great report, very helpful and she can follow it. Thank you.
- Following Agenda items potentially impact the one above:
 - Rebekah P. - Request to combine Literature and Travel expense lines on Treatment budget for 2026 to gain flexibility for chairperson to allocate approved funds as needed and determined by the committee
 - States MCDC, Rimrock, and Inpatient all will likely need literature of some form. If some treatment group is involved in corrections, like 50% of population, then their funding falls under Corrections. So MCDC and I believe Rimrock as well. Inpatient unit at Hospital is different, they not under corrections umbrella. Case of books is \$186. Also requesting some books into their library. Also requested Serenity Prayer cards. Not exactly sure what numbers will be but knows it will be a need in upcoming year. Can be taken back to groups to discuss. Also for trips to MCDC, most people who drive don't submit their gas receipts for reimbursement so thinks some can be reallocated.
 - Meghan clarifies so yes she wants an increase to cover upcoming literature expenses.
 - Lenore asks does combining line items really matter? Rebekah says is a decent idea, but in future could be helpful to have listed a good idea of how much literature is needed for each group. Lenore means shouldn't literature and expense lines stay separate? Rebekah states could reexamine after start of year.
 - Betty asks about literature for places like Rimrock, she states that they were asking about CPC. She asks ok if Rimrock is strictly an outpatient facility, do we believe that we have an obligation to furnish them with literature for alcoholics? Not sure what to think about it because MCDC and Hospital both inpatient. Should groups be able to vote on that first? Meghan states that's a good question but that Rimrock technically fall under Corrections so would be Pink Can funding.
 - Meghan wants to clarify if we keep line items separate would better help us track what is spent on literature vs what is spent on travel. If there was anymore literature needed and travel expense used, then she'd have to ask for

permission to use unused stuff for literature. But if we combine then she doesn't have to be as strict with travel vs literature and could be more useful going forward.

- Joanne asks how much is a case? 40 books, \$186, little baby big books. Went through in 3 months. Joanne states could we flip the line items, flip 800 to literature and 500 to travel.

- Crystal asks would hospital help cover costs of literature? Rebekah states that it was discussed with Hospital and agreed that AA would cover costs of literature.

- Joanne reminds that hospital is a psychiatric unit, not a treatment center. So we go in representing AA.

- Tim states his concern is whether or not we are following Traditions. Should groups be informed of this decision? It is the group's money that we are spending and they may have an opinion that brings different light to the decision (*Because budget would increase by \$100 total for Treatment Chair). Believes this is important enough that we should be bringing this back to groups first. Cool thing is that Spending Plan can technically be amended every month if needed.

- Joanne clarifies that it is an AA meeting that is going on in the Hospital, a little different than what the Warming Center meeting used to be

- Catherine states that relationship with hospital is delicate; some people in Hospital don't know whether or not they belong in AA. Vulnerable population. Jail had no way to regulate attendees (? Suddenly I lost train of conversation there)

- Russell states Traditions 5 and 7 so should be brought back to groups

- Joanne said something about Bridging the Gap.

- Crystal asks can we make motion to allocate this money from travel to literature for this month only and then take back to the groups? Not adding to spending plan for 2026 yet.

- Motion to give one time approval to move some travel money (\$186.67) into literature money for Treatment Chair to cover literature for Inpatient Hospital meeting.

- Tim clarifies there is money available in spending plan still

- Amy asks how long do people stay? Rebekah people stay 3-7 days. Short window.

- Gail says since Rebekah hasn't gone through majority of spending plan yet should be fine but we need to approve spending plan today. Tim states actually was due in October. Ok.

VOTE 22 Yes in room, 4 online. 1 abstention MOTION PASSES

o Lenore - Proposal to increase the budget for Alt DCM in 2026 so they can attend at least 1 assembly per year

- When Lenore was Alt DCM, she was able to attend Area due to extra in budget. Thinks it is super helpful for Alt to know what's going on at Area. Start with one a year, would add an additional \$450 based off of her budget. \$450 could potentially cover more than one if costs are cut with sharing room etc.

- Betty states thinks it is a fabulous proposal. Has worked out easily in past due to roommate compatibility but may be that each needs their own room in future so Alt DCM can step in if DCM is not available.

- Tim states his homegroup tries to send Alt GSR with the GSR. Has been good for Alt GSR in his group to have introduction with the GSR present.

- MOTION: Motion to increase the budget for Alt DCM by \$450 a year to attend at least one assembly a year.

- Matthew clarifies is it once a year or once a rotation? It is once a year. Should we change the position description? Tim states we should probably look at each of the chairs if we are adjusting their spending plan.

VOTE 23 in room, 3 online in favor. MOTION PASSES

- Tim Motion to table the 2026 Spending Plan until the groups have been informed of the proposed changes for the January business so groups can have a chance to discuss.

- Crystal asks for clarification on what GSR's are supposed to be bringing back. Rebekah says two separate things. Combining Literature and Travel expenses into one line item is option, may lead to loss of clarity in where Treatment chair spending is being used though. Or can increase the budget of the Treatment Chair by \$100. Wants to propose \$600 for travel/misc adjustment for next 3 months, \$800 for literature, as opposed to \$500 for literature and \$800 for travel. Treatment total of \$1400 with suggested changes as opposed to \$1300.
