- I attended the Area 40 Fall Assembly in Great Falls. This was my first time attending and I had a great experience. As a non-voting member it was so helpful just to observe and learn how things work. Everyone made me feel welcome.

## PI (Public Information), Ashley H.

The PI Committee met yesterday with 4 out of the 14 members present. We banded the new schedules and deliveries to the same locations are starting again. We are still mailing to 18 locations and are emailing a pdf to two.

Last month, the PI Committee had the idea of taping rack cards to the back of pamphlet locations. If all the pamphlets are taken at a certain spot, the rack card will remain that has a QR code so the meeting listings can still be accessed. I ordered 100 of these to be distributed with this quarter's deliveries. GSR's, please take one if you would like to add it to your pamphlet rack.

The meeting schedules for the October-December quarter were updated with a few changes. Common Solution in Belgrade now has a new meeting time, 6pm on Sundays. The Wednesday evening Veteran meeting was added to the schedule as well. I ordered 1100 this time because the hall drop off person ran out last month. They took more than usual in hopes that this won't happen again.

Sharon still updates the online meeting listing and changed Common Solution's time and updated the description for the Thursday Noon Big Book study.

I checked in with the two places I email schedule pdf's to. Love Inc said they hand them out, reference it throughout the month, or email a copy to those that need it. Kimberly from Bozeman Deaconess uses it to print copies that are available in the Emergency Department lobby and at her desk. She goes through 30 to 40 copies per month.

The Drop In Center meeting is still on hold. It was previously held at the Warming Center, but will now be in the new HRDC building. Valerie has a list of volunteers ready to speak once this gets going again. GSR's: if you know of anyone needing more service, this would be a great opportunity. It involves speaking for 15 minutes and answering questions about what AA can offer. This meeting isn't a formal AA meeting, it is a recovery-based meeting that is typically held the first and third Wednesdays of the month at noon.

We created a Holiday sub-committee that will make a plan for the 2026 Holiday announcements. This usually involves a radio ad, a couple newpaper plugs, and additional flyers announcing extra meetings that we hang on bulletin boards throughout the area.
